

### **Contest Rules**

One prize will be awarded. Contest begins on December 13, 2013 and ends on December 31, 2013. Winner will be notified no later than January 6, 2014.

DONATING IS NOT NECESSARY TO ENTER OR WIN. DONATIONS TO THE NATIONAL LGBT BAR FOUNDATION WILL NOT IMPROVE YOUR CHANCES OF WINNING.

Restrictions: All travel must be completed by July 1, 2014. Award letters/tickets are non-transferable. Award letters cannot be extended or renewed. A processing fee will be charged to reinstate travel not cancelled prior to ticketed departure (based on the class of service) – effective January 7, 2010. Passengers are not eligible for American AAdvantage mileage credit or any other promotional benefit that American may offer. No AAdvantage or Electronic Upgrades allowed.
