The Dodd-Frank Act made sweeping changes in the regulation of financial products and services, including banking, securities, and commodities law, some of which are now targeted for repeal by the new 112th Congress. At the same time, regulators are facing a July 21, 2011, deadline for implementing key mandates of the legislation.

In the midst of these developments, this webinar will feature commentary from one of the Act's primary authors, Congressman Barney Frank, Ranking Member of the House Financial Services Committee. Of particular interest to in-house and outside counsel to public companies, current and former SEC and FINRA staffers will discuss recent developments in the implementation
