## **PROGRAM DESCRIPTION:**

This live webinar will present an overview of current developments in the implementation of the recently passed Dodd-Frank Wall Street Reform and Consumer Protection Act. The Dodd-Frank Act made sweeping changes in the regulation of financial products and services, including banking, securities, and commodities law, some of which are now targeted for repeal by the new 112<sup>th</sup> Congress. At the same time, regulators are facing a July 21, 2011, deadline for implementing key mandates of the legislation.

The **National LGBT Bar Association's Financial Regulation & Reform Working Group**, in partnership with **Skadden LLP**, will present a live webinar on the Dodd-Frank Act and its effects on regulation of financial institutions and other public companies. The webinar will feature remarks from **Congressman Barney Frank**, as well as current and former officials from the Securities and Exchange Commission and the Financial Industry Regulatory Authority. Speakers include **John Ramsey**, Deputy Director, SEC Division of Trading and Markets; **Brian V.
