Sweepstakes Rules

Restrictions: The gift certificates are subject to availability. No cash value.

Eligibility: Sweepstakes is open only to residents of the United States, 21 or older as of the date of entry. Sweepstakes is void where prohibited by law. Participation in the sweepstakes constitutes your agreement to be bound by these Sweepstakes Rules.

How to enter: All individuals who make a donation of \$20 or more to the National LGBT Bar Foundation between October 3, 2011, and November 1, 2011, will be automatically entered in the sweepstakes.
